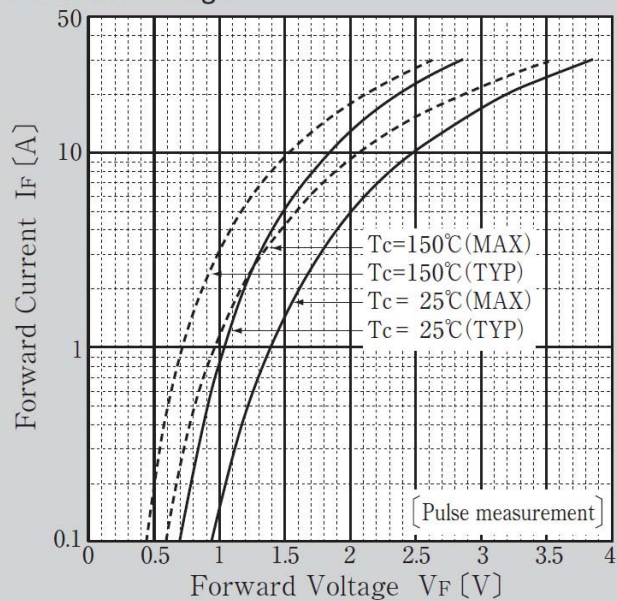

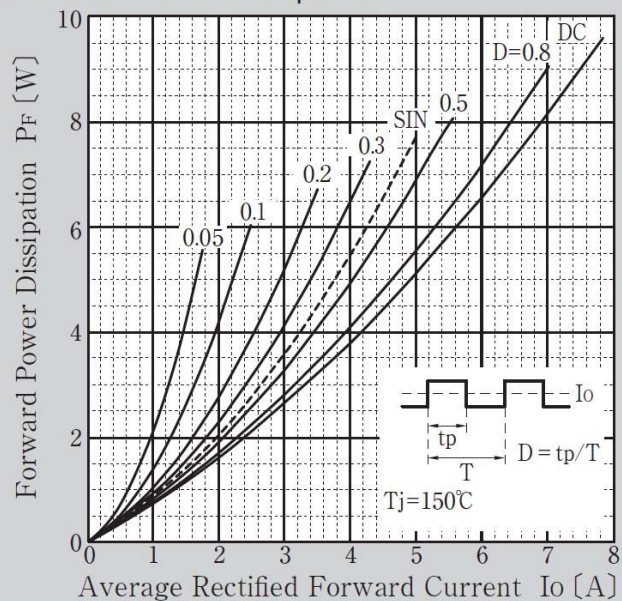

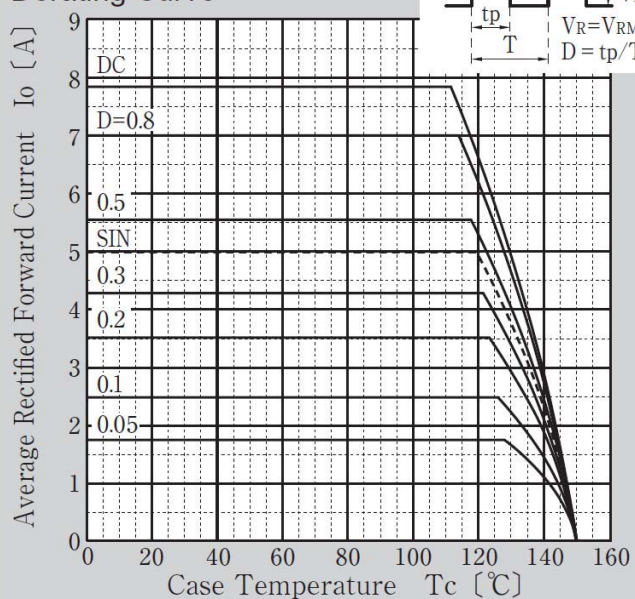
Forward Voltage



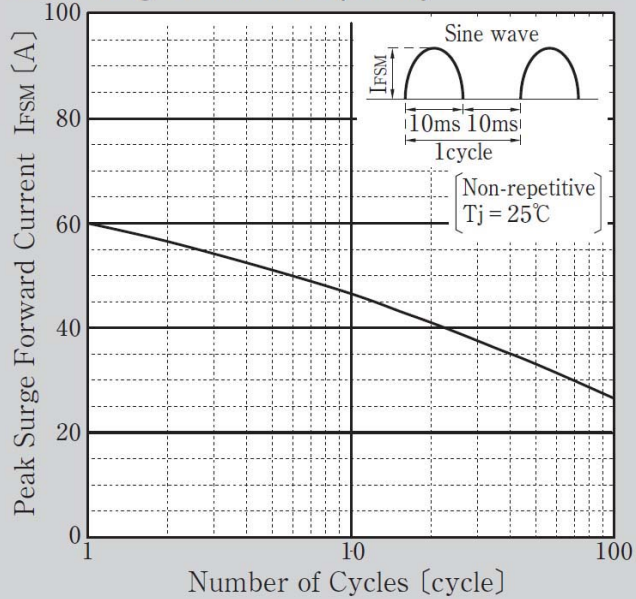
Forward Power Dissipation



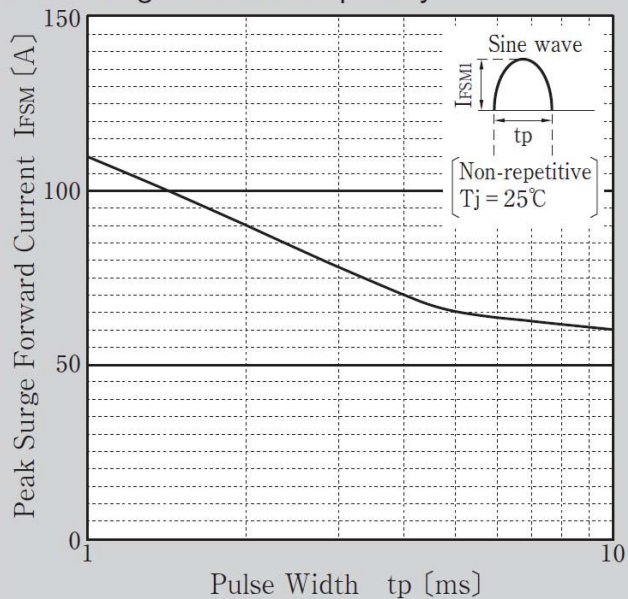
Derating Curve



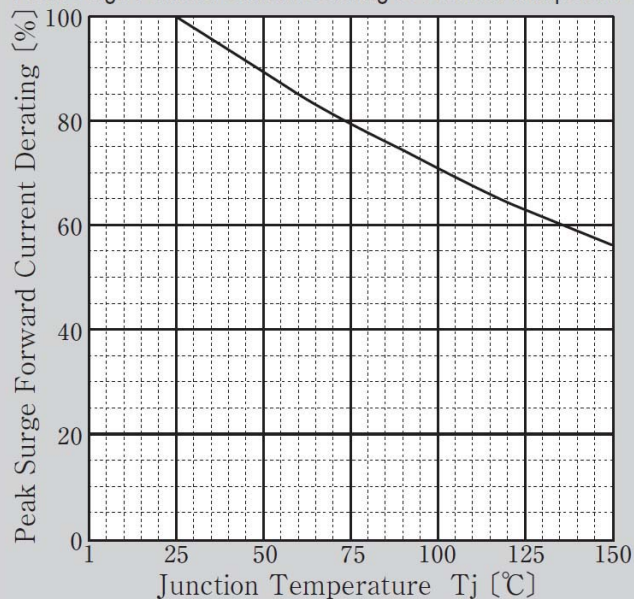
Peak Surge Forward Capability



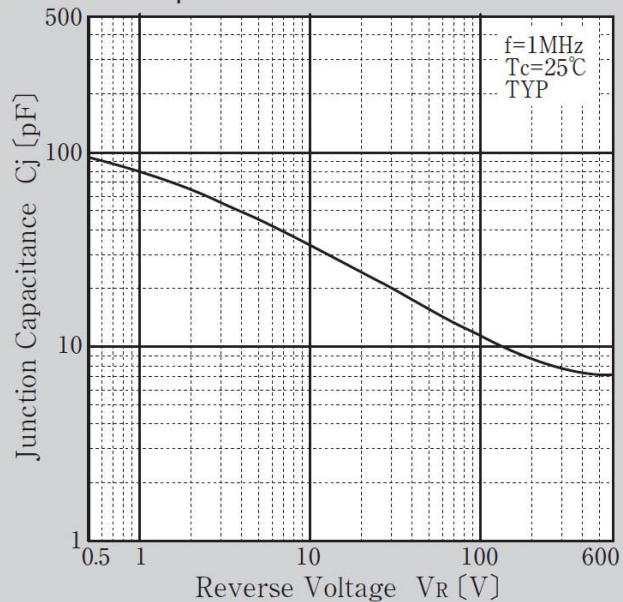
Peak Surge Forward Capability



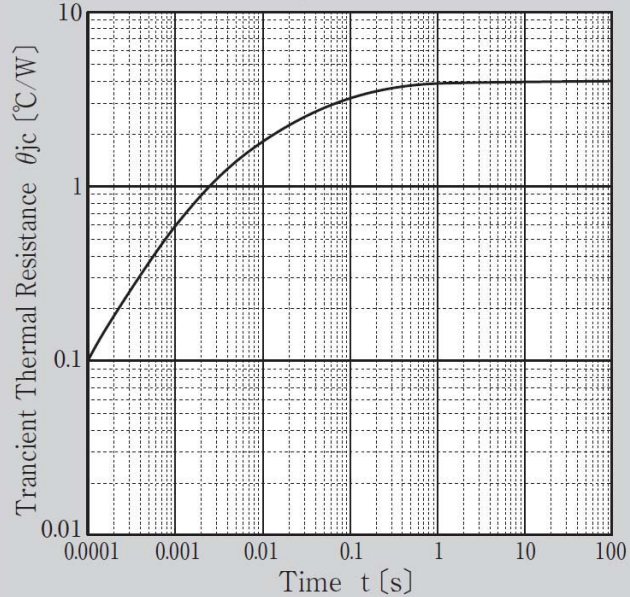
Peak Surge Forward Current Derating vs Junction Temperature

Transient Thermal Impedance

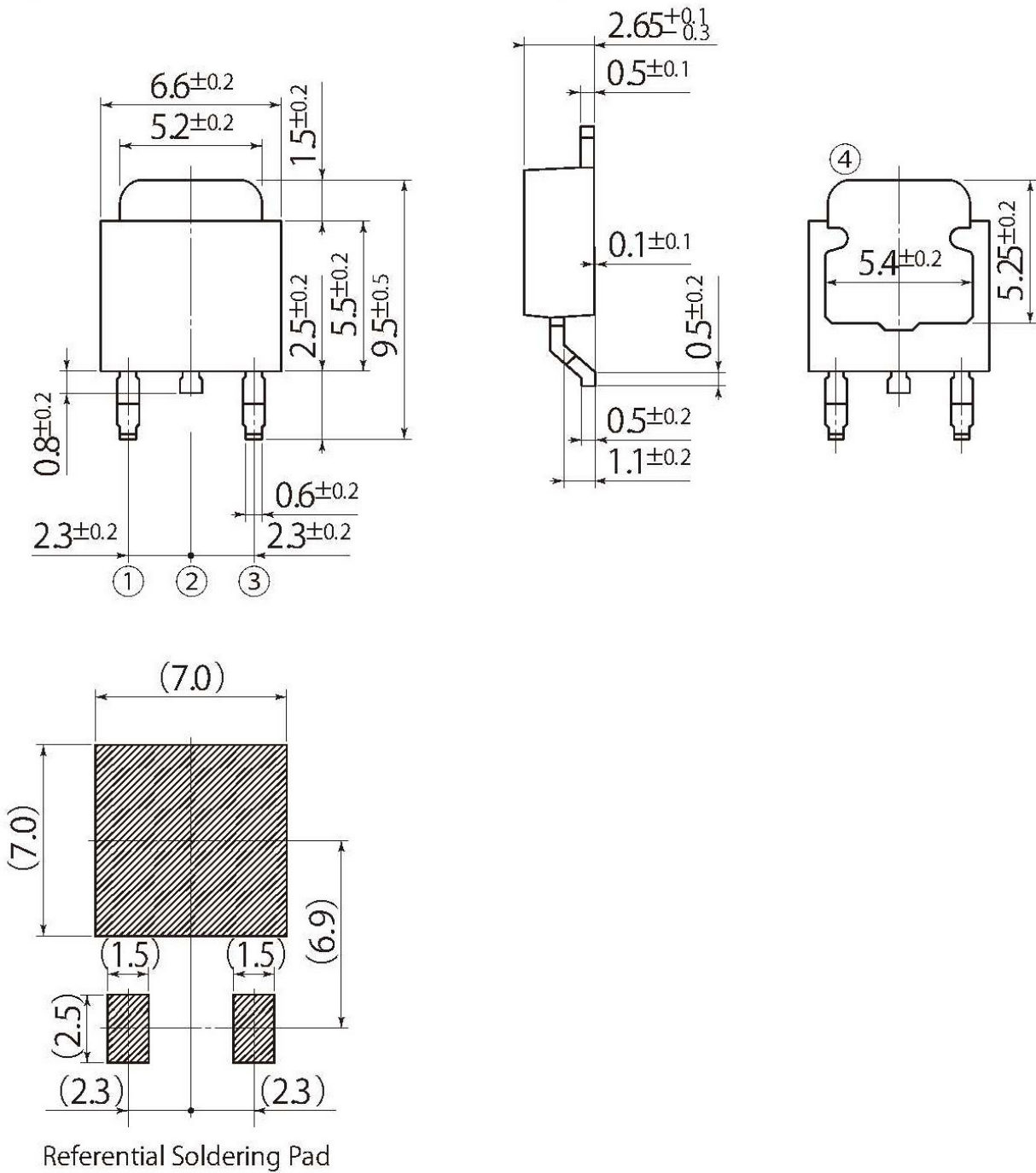
