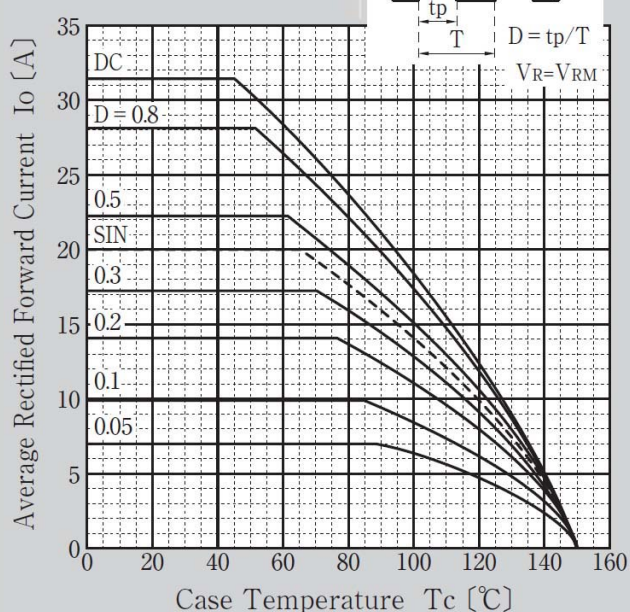
### Forward Voltage



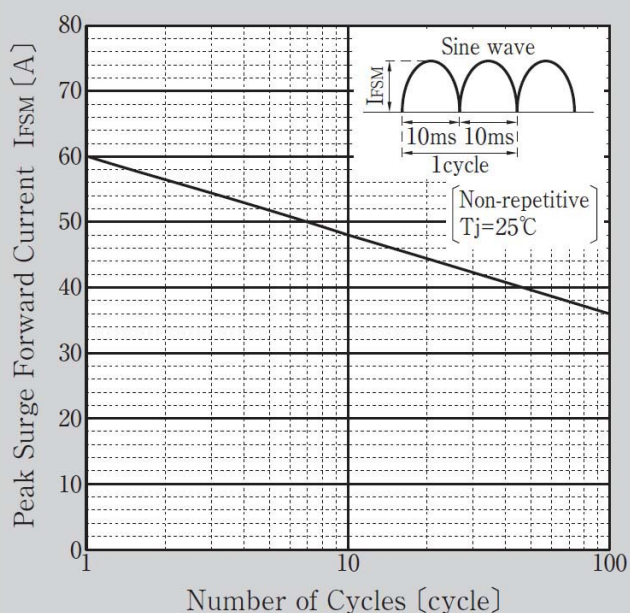
### Forward Power Dissipation



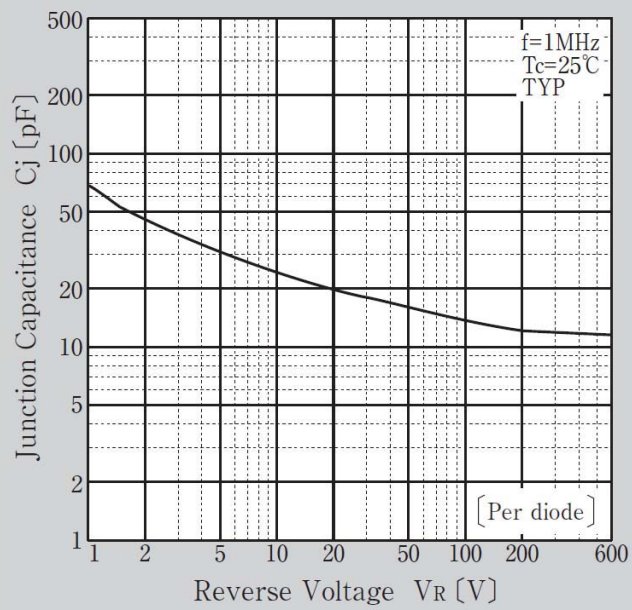
### Derating Curve



### Peak Surge Forward Current Capability

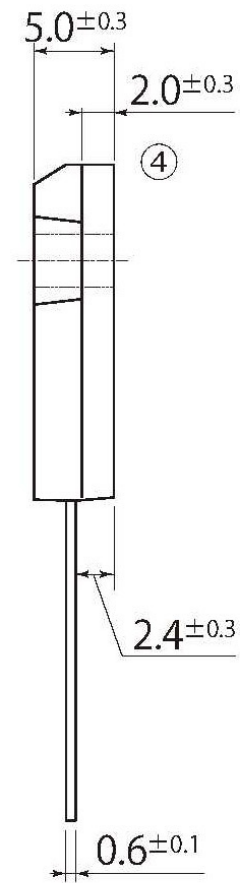
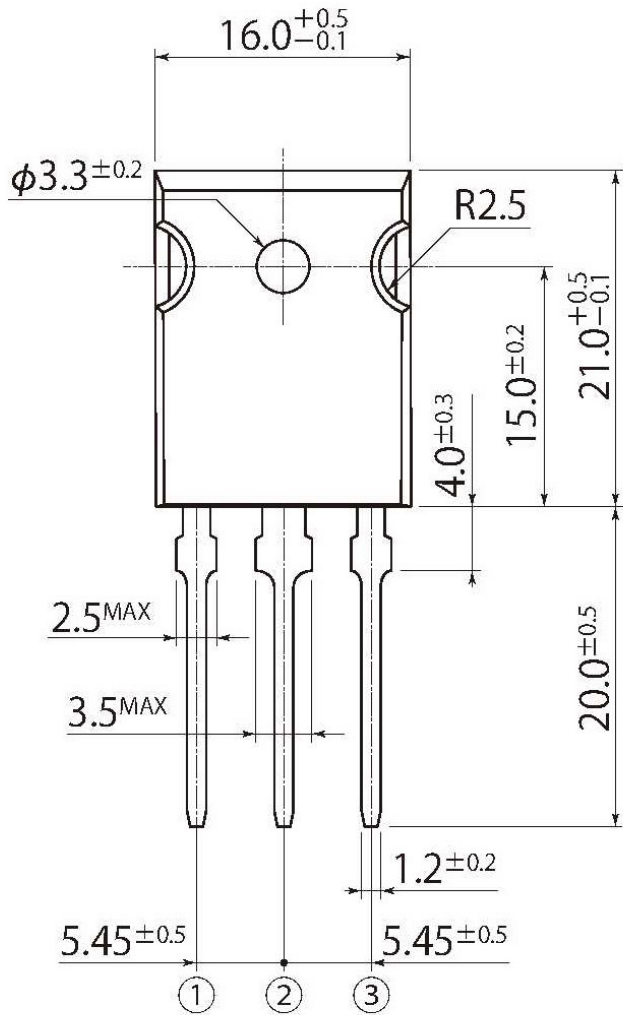


### Junction Capacitance
